3. CAPACITY OF THE VENDOR:

The Vendor sells as the Beneficial owner.

4. DATE OF COMPLETION

5. TITLE DOCUMENTS

The Vendor covenants to cooperate with the Purchaser, where necessary, to ensure that all relevant documents to the said Land are obtained by the Purchaser.

6. INDEMNITY

- 6.1 The Vendor guarantees that the Land is free from all customary and legal encumbrances whatsoever and hereby undertakes to indemnify the Purchaser against alldamages, losses, liabilities or otherwise which the Purchaser may incur or sustain directly by reason of any defect in the Vendor's title. Provided that this clause can onlyapply if the Purchaser does not breach any term of this Agreement.
- 6.2 The Purchaser shall indemnify the Vendor for any loss incurred, money expended, or damages suffered in the event of issues arising from the funds used for payment of the Land as being from a fraudulent source.

7. DEFAULT, REFUND CHARGES

- 7.1 The Purchaser shall pay contingency fee of **30%** on the total outstanding instalment amount upon failure to pay up any monthly instalment.
- 7.2 This contract of sale shall be terminated upon default of payment for two (2) consecutive months and the Purchaser shall be allocated the Land based on the amount so far paid up, or Purchaser shall be moved to another location that the Purchaser's money so far paid up can afford.
- 7.3 Ordinarily, the Vendor does not refund monies paid for the purchase of landed property. However, in the event of consistent default or unforeseen circumstances that may result to refund the following applies.
 - 5% administrative fees shall be deducted.
 - where the Purchaser brings in a buyer for the property, the Vendor shall immediately refund the Purchaser upon receipt of the purchase price from the new buyer less the 5% administrative fee.
 - Where the Vendor has to sell the Land on behalf of the Purchaser, a 10% sales commission applies and will also be deducted. Note the Purchaser has to allow time for the sales.
- In the event the Purchaser demands immediate refund without allowing time for the re-sale of the Land, the Vendor shall refund only 40% of the total amount paid by the Purchaser.
